

# Book Review: "A Long Obedience in the Same Direction" by Eugene H. Peterson

ccasionally you pick up a book—
particularly a devotional book—and the
contents not only speak to you, they often
shout at you. Eugene Peterson's "A Long Obedience
in the Same Direction: Discipleship in An Instant
Society" was such a book for me. He
wrote this book nearly forty years ago
but its contents are as relevant today as

We are still a society that looks too often for quick fixes and instant gratifications. Peterson's book examines Psalms 120-134, also called the Song of Ascents, and teaches the reader how they may grow in Christian discipleship. Topics in the 15 psalms include repentance, worship, service, joy, work, happiness, humility, community and blessings. Peterson quotes biblical writers, theologians, an atheist (Nietzsche, from whom he borrows the title of the book), novelists and testimonies of Christians who pursued God at all costs.

when it was first written.

Peterson begins the book with the statement that Christian disciples too often navigate this world as tourists rather than as pilgrims. We think anything worthwhile can be acquired once, so we develop the lifestyle of a tourist and only want the high points. When we become a pilgrim, we become a person who spends their life

going someplace, going to God, and our path for getting there is the way of Jesus.


The psalms used in this book provide support, courage and inner direction for getting the reader where God is trying to lead them in Christ. This book is meant to be a guidebook and map for those who are

looking to maintain a mature, growing, active and meaningful lifestyle of a disciple in today's cultural milieu.

Peterson has said that seventeen publishers rejected his manuscript, saying there was no "niche" in the market and it was irrelevant to the concerns of the contemporary North American. One asked, "Who wants to purchase a book with the words 'long' and 'obedience' in its title?" Yet "A Long Obedience in the Same Direction" has become one of the new classics of devotional and spiritual growth studies.

I have read this book more than four times, and I glean something new for my personal growth each time. In fact, I highly recommend that persons read the book then purchase the audio book, which is narrated by Lloyd James whose voice is pleasant, moving and emotive.

The depth of information and inspiration in this book will stay with you for some time as you realize that this walk we have with Christ involves a long obedience in the same direction.

outh 2019 was the national gathering of United Methodist Youth put on by Discipleship Ministries. The quadrennial event was held in Kansas City, Missouri from July 10-13. Youth from both the Oklahoma Annual Conference and Oklahoma Indian Missionary Conference attended the event.

In total, Youth 2019 had over 3,100 attendees. The event provided a space for youth to connect with other youth and their leaders, denominational leaders and connectional agencies, and to learn about the wide variety of ministries of the United Methodist Church.

The event's theme was "Love Well," based on Romans 12:9-10. Participants were challenged to expand their understanding of what it means to love God, self, and others, and to do it well. Young people participated in small groups, workshops, Bible study and outreach, collectively packing over 100,000 bags of food. OIMC youth led an opening prayer for worship participated in a panel discussions on growing up Native and Native issues.

The South Central Jurisdiction hosted a gathering during the event for youth from across the jurisdiction to join together and meet one another. Representatives from each conference within the jurisdiction shared about what is going on in their conference, and they elected four young people to attend the 2020 Jurisdictional Conference as official observers. On Friday evening, Oklahoma City University hosted a pizza party for the Oklahoma groups to gather for food and fellowship.

### Connectional Table approves legislation creating new U.S. structure

Legislation could be voted on during 2020 General Conference

hicago, IL—The Connectional Table approved sending legislation to General Conference 2020 that will create a new structure for churches in the United States, called a regional conference, during an online meeting July 18, 2019.

The proposed legislation stipulates that the U.S. Regional Conference will have geographic boundaries congruent with the territory of the U.S. annual conferences. Jurisdictions will continue to function with their current powers and duties, including their process to elect bishops.

"The current proposal will help the General Conference to focus its work on matters truly global," says Bishop Christian Alsted, chair of the board, "and offers the church in the United States a connectional structure to deal with matters pertaining specifically to the U.S. context, including the development of strategies and priorities, pension and healthcare issues and, not least, adaptations to the Book of Discipline."

During the Connectional Table's meeting in April 2019, the body approved bringing a legislative proposal to GC2020 to create a U.S. Central Conference and sent the proposal back to the U.S. Contextual Ministries Advisory Group for further work. Concerns surfaced at this meeting and in the Council of Bishops about calling the U.S. structure a central conference. Calling it a regional conference instead acknowledges the painful, racist history and still-existing wounds associated with the former Central Jurisdiction in the U.S.

Creating the U.S. Regional Conference will be done in two stages:

■ Stage I will form a committee of the General Conference, with legislative function, to deal with U.S. Region – Adaptable disciplinary

provisions, U.S.-related resolutions, and nondisciplinary petitions concerning U.S. matters.

Stage II will form the U.S. Regional Conference, and the Stage I committee will end its work.

"We feel that the two-stage process we are proposing best meets the needs of the U.S. to do adaptive work," says Judi Kenaston, chair of the CT's advisory group. "Stage I will allow us to function in the interim and process legislation that is specific to the United States. It allows Central Conference input while also taking a burden off the General Conference to deal with legislation that does not affect the whole church. Stage II, which establishes a U.S.

> Regional Conference, is a long-term solution for dealing with U.S.specific legislation that can

allow the U.S. to have parity with the Central Conferences that already do adaptable work."

Because the regional conference is a new body and different than a central conference, the proposed legislation will add a new ¶11. Article IV.—"There shall be a regional conference for the Church in

the United States of America, with such powers, duties, privileges, and limitations as are hereinafter set forth." Also, a new Section VI. Regional Conferences in the Constitution would be added.

Proposals for the U.S. to have a structure similar to a Central Conference began as early as 1924, with a formal proposal by the Board of Foreign Missions coming to General Conference in 1928. The Connectional Table began work on this issue in 2005, when a joint task force on the Global Nature of the Church was established with the Council of Bishops.

When the work on the General Book of Discipline began at General Conference 2012, the need for the churches in the U.S. to have a place to do adaptable work took on a greater sense of urgency. CONTINUED ON NEXT PAGE

The Connectional Table began working alongside the Standing Committee on Central Conference Matters in 2013, when it formed a Worldwide Nature Collaboration Group.

As the global church responds to the recent 2019 Special Session, new legislative proposals for a U.S. structure have been brought forth. None pre-date the Connectional Table's work or have the same focus.

"The legislation, as currently written, will not address our impasse over human sexuality," says the Rev. Kennetha J. Bigham-Tsai, chief connectional ministries officer for the Connectional Table. "However, it will help unburden the General Conference and facilitate U.S. adaptable work of other kinds. It is crucially important for the health of our church going forward to have a place where the U.S. can make decisions about its mission and ministry."

"NSO has helped me so much. They helped me to get a roof over my head and have a safe, secure place. I think this is the best place for me."


Corey has set his sights on achieving his GED and improving his communication skills. He also enjoys helping his fellow residents with anything they may need and helping with the gardening outside his new home.

# NPNP 2020 grant applications due Aug. 31

ew People New Places is preparing for its sixth year of awarding grants to ministries that "reach new, younger, and more diverse people to become world-changing disciples of Jesus Christ." Applications are due by 11:59 p.m. on Aug. 31. Any Conference ministry and churches of every size may apply.

To date, grants ranging from \$1,970 to \$150,000 have been awarded to 73 ministries in all eight districts across the state. These ministries have seen a total of 299 professions of faith, with some ministries able to replicate programs in new locations.

Though no request is off-limits, every request must show how the proposed project relates to making new disciples and demonstrate the steps between the initial project and new discipleship. Projects should also show a plan for financial sustainability within three years. Applicants should be able to show strong support from their church, District Mission Strategy Team and District Superintendent.

The Oklahoma Conference first addressed family separation when Bishop Jimmy Nunn shared support for a Faith Leaders Statement issued by the Council of Bishops and leaders of other faith traditions. ircle of Care makes it their mission to provide Christian help, healing and hope to children and families in crisis to ensure a safe, healthy and spiritual future.

Three programs help them achieve this mission: Foster Care Services, Preparation for Adult Living (PAL), and Pearl's Hope.

#### **Foster Care Services**

There are nearly 8,000 children in Oklahoma state custody, and on any given day, approximately 150 are in need of a foster home. Circle of Care works to address this need by recruiting, training, certifying, and providing ongoing support for new foster parents.

In addition to supporting families, Circle of Care is building eight foster homes across the state so that siblings can live together.

#### **Preparation for Adult Living (PAL)**

The PAL Program is for older students who are aging out of foster care or referred from behavior modification facility, state agency, or United Methodist Church. Students in the PAL program often lack the family support they need to finish school. PAL helps these students complete their education, learn financial literacy and prepare for independent living.

#### Pearl's Hope

Pearl's Hope provides transitional housing and other support services for single mothers and their children. This ministry helps fill a gap left by local shelters who cannot accept large families or boys over the age of 13. Pearl's Hope keeps families together.


